"DISPÕE SOBRE A ABERTURA DE CRÉDITO SUPLEMENTAR NO ORÇAMENTO DO FUNDO MUNICIPAL DE SAÚDE."

O PREFEITO MUNICIPAL DE CORDEIRO, ESTADO DO RIO DE JANEIRO, NO USO DAS ATRIBUIÇÕES LEGAIS, E DE ACORDO COM AS LEIS MUNICIPAIS Nº 2214/2018 e 2276/2018,

DECRETA:

Art. 1º - Fica aberto no Orçamento vigente do Fundo Municipal de Saúde, o crédito suplementar no valor de R\$ 2.094.155,39 (dois milhões, noventa e quatro mil, cento e cinquenta e cinco reais e trinta e nove centavos) para reforço de dotações que se tornam insuficientes no exercício corrente.

Art. 2º - Os recursos para atender o art. 1º são decorrentes de anulação parcial de dotações orçamentárias do próprio fundo, conforme demonstrativo abaixo:
